

Industrial gas is used to drive industries and factories with large volumes of demand. We are experts. In the installation of LPG distribution systems, trusted by industries and factories.



Other Business

Power Plant

The company's subsidiaries operate combined cycle power plants with capacity of 230 MW and diesel power plant with capacity of 10 MW

▶ Combined Cycle Power Plant

Operated by the company associate, Myanmar Lighting (IPP) Co. Ltd. It is a highefficient combined cycle power plant in Mawlamyine, Myanmar. It produces electricity and sales to Myanmar government.

▶ Diesel Power Plant

Operated by the company associate, Southern Myanmar Development Co., Ltd. It is located in Anin, Myanmar. It produces electricity and sales to households and industries in the surrounding area.



Cylinder Manufactory

The company produces and distributes LPG cylinders in accordance with international standards. The company can produce LPG cylinders in various sizes to serve local and overseas markets.

Oil Terminal

It operates oil storage and deep seaport with 4 deep sea berths and 14 oil storage tanks with a storage capacity of 1,000–100,000 DWT. Its berths are able to load crude oil, gasoline base, diesel, and JET*A1 and can distribute petroleum both locally and overseas.

Transportation and Services

► Land transportation of petroleum

The company has a subsidiary with expertise in the transportation of petroleum. Its priority is safety transportation, which capable of transporting oil up to 1,149,000 liters and LPG up to 3,495 tons

▶ Marine Transportation of petroleum

The company's subsidiary operates marine transportation of petroleum, ammonia, and other petrochemicals. It has 28 LPG tanker vessels with a combined loading capacity of 340,000 tons. Of which 7 tankers are very large. Gas Carrier (VLGC). It provides international standard service to serve both local and overseas.
