Subject Explanation of the change in operating results for the 2nd quarter and six-month period ended June 30, 2025 over 20% compared with the same period of the previous year

Siamgas and Petrochemicals Public Company Limited would like to explain the change in operating results for the 2nd quarter and six-month period ended June 30, 2025 compared with the same period of the previous year as follows:

For the three-month in Q2/2025 compared with the same period of the previous year

Siamgas and Petrochemicals Public Company Limited and its subsidiaries (Siamgas Group) had the operating results for the three-month period in Q2/2025 with the net loss attributable to owners of the parent company of Baht 559.85 million compared with the same period in Q2/2024, the net loss attributable to owners of the parent company of Baht 10.36 million which net loss increased by Baht 549.49 million or 5,303.96% with main reasons as follows:

1. Revenue from sales, transportation, services

In Q2/2025, Siamgas Group had revenue from sales, transportation and services of Baht 16,616.37 million compared with the same period in Q2/2024 of Baht 20,917.02 million which decreased by Baht 4,300.65 million or 20.56%. Mainly resulted from the overseas LPG trading business which has sales volume lower than the same period of the previous year. The average LPG world price for 3 months as at Q2/2025 and Q2/2024 was USD 598 per metric ton and USD 591 per metric ton respectively.

2. Cost of Sales & Services, Cost of Transportation and Gross Profit

During the period of Q2/2025, Siamgas Group had cost of sales, services and transportations of Baht 16,564.19 million compared with Q2/2024 of Baht 20,318.07 million which decreased by Baht 3,753.88 million or 18.48%. which was resulted from the decrease in revenue, as mentioned in the revenue section above.

Siamgas Group had generated overall gross profit for Q2/2025 of Baht 52.18 million or equal to gross profit of 0.31% compared with gross profit for Q2/2024 amounting to Baht 598.95 million or equal to gross profit of 2.86%. The gross profit decreased by Baht 546.77 million or 91.29%. Mainly reason from the decrease in revenue, as mentioned in the revenue section above. In addition, at the end of Q2/2025, The Group recorded a provision for the diminution in value of inventories amounting to Baht 155 million in respect of the overseas oil trading business.

3. Financial Costs

In Q2/2025, Siamgas Group had the financial costs of Baht 300.28 million, compared to Q2/2024 amounting to Baht 249.36 million which increased by Baht 50.92 million or 20.42%. Main reason was increased of long-term borrowings during the period, arising from a subsidiary's purchase of a LPG vessel for use in transportation business, amounting to Baht 1,882 million.

For the six-month in Q2/2025 compared with the same period of the previous year

Siamgas Group had the operating results for the six-month period in Q2/2025 with the net loss attributable to Owners of the parent company of Baht 434.78 million compared with the same period in Q2/2024, the net profit attributable to Owners of the parent company of Baht 625.37 million which net loss increased by Baht 1,060.15 million or 169.52% with the main reasons as follows:

1. Revenue from sales, transportation, services

Siamgas Group had revenue from sales, transportation and services for the six-month period in Q2/2025 of Baht 36,225.08 million compared with six-month period in Q2/2024 of Baht 44,177.71 million which decreased by Baht 7,952.63 million or 18.00%. Mainly resulted from the overseas LPG trading business which has sales volume lower than the same period of the previous year. The average LPG world price for 6 months as at Q2/2025 and Q2/2024 were the same at USD 609 per metric ton and USD 611 per metric ton respectively.

2. Cost of Sales & Services, Cost of Transportation and Gross Profit

During the period of Q2/2025 for the six-month, Siamgas Group had cost of sales, services and transportations of Baht 35,414.92 million compared with six-month period in Q2/2024 of Baht 42,343.15 million which decreased by Baht 6,928.23 million or 16.36% which was resulted from the decrease in revenue, as mentioned in the revenue section above.

Siamgas Group had generated overall gross profit for Q2/2025 of Baht 810.16 million or equal to gross margin of 2.24% compared with gross profit for Q2/2024 amounting to Baht 1,834.56 million or equal to gross margin of 4.15%. The gross profit decreased by Baht 1,024.40 million or 55.84%. Mainly reason from the decrease in revenue, as mentioned in the revenue section above. In addition, at the end of Q2/2025, The Group recorded a

provision for the diminution in value of inventories amounting to Baht 155 million in respect of the overseas oil trading business. Gross Profit as table below;

3. Financial Costs

For the six-month ended June 30, 2025, Siamgas Group had the financial costs of Baht 624.85 million, compared to Q2/2024 amounting to Baht 521.55 million which increased by Baht 103.30 million or 19.81%. Main reason was increased of long-term borrowings during the period, arising from a subsidiary's purchase of a LPG vessel for use in transportation business, amounting to Baht 1,882 million.
